Datu Jasotzaile gisa erregistratzeko hiru erabiltzaile mota daude: Bazkideak, Hirugarren Enpresak eta Erabiltzaileak.

1. Bazkideak

Jatorrizko Ekipoen Fabrikatzaileak (OEM) eta Bizikleta Saltzaile Independentek (IBD) Bazkidetzat hartzen dira. OEM edo IBD batekoa bazara, Bazkideen Atarian sartzeko aukera izan beharko zenuke jada. Joan <https://portal.bosch-ebike.com/data-act?returnTo=%2Fdata-act> helbidera eta sartu zure SingleKey ID-arekin. Orduan, Bosch eBike Systems-eko kontu-kudeatzailearekin harremanetan jartzeko mezua ikusiko duzu.

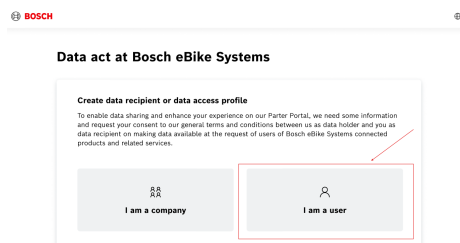

1. Партньори
